

**We're so excited that you're going to become a member of Mosaic Yoga. Here's what you need to know about the terms and benefits of membership.**

As a member in good standing, you get:

- Unlimited access to all drop-in classes;
- 10% discount on retail purchases (pre-tax);
- Discounts on workshops, events and retreats (10-50% pre-tax);
- Free mat storage;
- Up to three pauses per contract year. Pauses can be as short as seven days and you can pause up to ninety days per contract year;
- Right to cancel at any point by giving thirty days notice and making one final regular monthly payment;

In return, you will:

- Pay a one-time registration fee of \$25 plus HST;
- Keep your payment information (debit or credit card) updated and in good standing;
- Pay a \$15 penalty charge per payment failure;
- Use the online Membership Pause form to pause and the Membership Cancellation form to cancel;
- Pay \$90 plus HST every thirty days (10% discount (pre-tax) for students enrolled in full time programs and adults who are sixty years of age or older);

- 1) I \_\_\_\_\_ am at least 18 years of age.
- 2) I agree to allow Mosaic Yoga Inc. to charge my credit or debit card \$90 + HST monthly in advance until I cancel my membership.
- 3) I agree to inform Mosaic Yoga Inc. of changes to my credit card information (e.g., expiry date) at least 14 days before the next pre-authorized payment, or to make the changes myself online in advance of my next payment due.
- 4) I acknowledge that there is a non-refundable charge of \$15.00 for failed pre-authorized payments.
- 5) I acknowledge that I may place my membership on hold up to three times per contract year, for a minimum of 7 days per hold, up to a maximum of 90 days TOTAL hold time and must complete a pause form online in each instance.
- 6) I acknowledge that to request a hold on my membership and payments, or to cancel my membership I must complete the online form found at [mosaic瑜伽.ca](http://mosaic瑜伽.ca) at least 14 days prior to the requested pause or cancellation date, and that pauses and cancellation only come into effect when the studio provides its express approval to the member by way of email confirmation.
- 7) I acknowledge that I may cancel my membership any time by giving thirty days advance notice through the online cancellation form and making one final payment of \$90 plus HST (student/senior discount where applicable). I will have full access to the benefits of membership for thirty days after making my final payment.
- 8) I acknowledge that after 12 months/12 payments, Mosaic Yoga Inc. will continue to automatically charge my credit card monthly unless I request to cancel by giving thirty days advance notice through the online cancellation form (ie my contract is auto-renewing).
- 9) I acknowledge that my membership is non-refundable, non-transferrable, and may not be shared. No rights or privileges granted by this membership can be transferred.
- 10) I agree to keep and obey all rules and regulations now in force or in the future prescribed by Mosaic Yoga Inc. for the use of the Mosaic Yoga Inc. facilities, premises and equipment therein.
- 11) I acknowledge that Mosaic Yoga reserves the right to revoke this Membership Agreement if I fail to keep and obey any of such rules and regulations.
- 12) I acknowledge that Mosaic Yoga Inc. may change the membership fee under this Membership Agreement with 30 days notice.
